**Zoning Permit Applications:**

1. Permit No. 25-22
  - a. 216 Village Glen Drive River Road, Peter Drasher
    - i. New Construction, Accessory Structure, (Greenhouse) Residential

Permit 25-22 regards the installation of a new 12'x 16' custom Greenhouse to the South of the main house. The project would be set on piers or skids including electricity lighting and possibly heat. The Design Advisory Committee (DAC) had reviewed the application a week prior.

Powers opened the floor to the Drasher to present. Peter Drasher introduced the project, walking the Board through a site plan of the proposed siting, product specifications for the roofing, windows and lighting. and addressing distance from a water line setback nearby. Brodie asked what he was going to be growing, Drasher replied that he is going to be growing Dahlias. Powers opened the floor to questions. Brodie commented that Drasher's property is in the flood plain and produced a map of the flood plain for review. It was noted that the gardens, Greenhouse and house are outside the flood plain. Powers then read aloud the recommendations of the DAC. It was resolved that with a DAC recommendation and given no further questions, the proposal would be voted on.
